PRICES: Prices are subject to change without notice. All orders shall be invoiced at the prevailing price at time of shipments. Due to the increasing costs of BRASS and BRONZE products, prices will be quoted on an order by order basis.

DIMENSIONS: All dimensions and similar data in this catalog are nominal and subject to manufacturing variations.

MINIMUM ORDER: The minimum order shall be \$50.00

TERMS: Net 30 days; no discounts are permitted.

ORDER QUANTITY: Most products are box bulk packed in quantities of (50) or (100) pieces.

CREDIT: Three trade references, Bank and Company Officers.

SHIPPING: All prices are F.O.B. Columbia, PA. Freight plus a handling charge will be added to all orders. Unless specifically requested by the Customer, Peerless reserves the right to select the means of shipping the ordered products. Peerless, after delivery of the product to the Carrier, assumes no responsibility for delay, damage or losses beyond its control. Please check contents and quantities of all shipments against the packing list upon receipt. Written notification of any shipping errors must be received by Peerless within thirty (30) days of shipping date to effect correction. (Canada 45 days)

RETURNS: Peerless shall refuse to accept and/or credit any products returned to it without prior notification by the Purchaser and Return Authorization issued by Peerless Hardware Manufacturing Co. Inc. A minimum 25% Restocking Charge will be made on all returns accepted. Written notification of any defect must be received by Peerless within thirty (30) days of shipping date to effect correction. (Canada 45 days)

SPECIFICATIONS AND DESIGNS: Peerless reserves the right to make changes and improvements to the design and/or specifications of all its products without prior notice.

WARRANTY:

The goods sold in this catalog/price sheet are warranted free from defects in workmanship and materials for 90 days from date of purchase.
